Identification Documents



By Churches of Christ Foundation (the Foundation) staff:

We can verify identity from the original document/s by completing the Identity Verified – Individual – Foundation form. Documents in a foreign language not understood by us must be translated into English by an accredited translator.

By original certified copy:

Copy is to be certified as a true copy by any person who is entitled to witness under the Commonwealth of Australia Statutory Declaration as defined in the Statutory Declarations Regulations 2018 such as Justice of the Peace, Commissioner of Declarations, Police Officer, Minister of religion registered under Subdivision A of Division 1 of Part IV of the Marriage Act 1961

Please ensure that the copy is <u>very</u> clear and includes all the verifiable information. e.g. both sides of the Driver's Licence.

We must be able to read all information on the certified copy. The original certified copy is to be posted or hand delivered to our Kenmore office. A copy of the certified copy such as a fax or an attachment to an email will not be accepted.

Documents in a foreign language must be accompanied by a copy translated into English by an accredited translator.
