What does Package Management cover?

Package management is the ongoing administration and organisational activities associated with ensuring the smooth delivery and management of your Home Care Package. It may include the costs for preparing monthly statements, managing your package funds and compliance and quality assurance activities required for Home Care Packages.

It does not include costs that are unrelated to supporting your care or costs associated with the provider's running of their business such as marketing, office rent, insurance, or activities completed before you enter into a Home Care Agreement with them. Where necessary, providers will include any other administration costs within the unit price for home care services, so you can see the all-inclusive cost of delivering the service.
